What is Estate Planning?


Creating a plan to distribute your assets during your life or upon death

Objectives – Arrange your financial affairs for

Tax efficient income during your lifetime
Tax efficient dependent support after death
Tax efficient transfer of wealth
Protection of your assets

Basic Terminology

- Will and testator
- Estate
- Intestate
- Beneficiary
- Executor



Importance of a will

- Positive net worth
- Distributed as you want
- Financial / Estate Planner
 - Save on tax
- Professional lawyer / Notary
 - Save on possible probate fees
 - Follow strict BC laws
 - Absence of bias
 - Avoid mistakes / confusion / litigation

Choosing your executor

- One primary and an alternate
- Younger, trustworthy, good communicator
- Financially savvy
- May be family
- Fee 1.5% to 3%-5% of estate





Executor's duties

- Attend to funeral and burial expenses
- Inventory the assets
- Initiate Probate if required
- Pay debts and Taxes
- Distribute remaining assets

How do you avoid probate?

- Designate beneficiaries
- Establish joint ownerships
- Transfer property to Joint Tenancy
- Dual wills
- Give away possessions before death
- Create a Trust

Probate Fees

- If \$25,000 and below zero
- If > \$25,000 up to \$50,000 0.6%
- If >\$50,000 1.4%
- Court filing fee for estates over \$25,000 - \$200

When are fees collected

Upfront

How are fees charged

Gross asset value





Power of Attorney

- Legal authority
- Enduring POA
- With or without Restriction
- Responsibility and control ends upon death

Other things to consider

Guardians

- Child guardian
- Estate guardian

Digital property / passwords

- Banking
- Social media
- Emails
- Audio + video subscriptions




Advance health care planning

- Representation Agreement
- End of life wishes,
 - DNR do not resuscitate
 - Life support
 - Medical assistance in dying (MAID)
 - Natural dying
 - Anointing of the sick
 - Reconciliation prayers




Legacy through Planned Giving




