Bylaw Schedule B: Rights of Interment Regulations

1.1 INTERMENT RIGHTS

- 1.1 **Bylaw Compliance:** The sale, purchase and use of an Interment Right in Gardens of Gethsemani Catholic Cemetery, Surrey (the Cemetery) shall comply in every way, as is applicable, with '*The Roman Catholic Archdiocese of Vancouver Cemetery Management Bylaw*' (the Bylaw) and any regulation set out in this Schedule.
- 1.2 **Interment Rights:** The following criteria sets out the Rights of Interment and their permitted uses for Gardens of Gethsemani Catholic Cemetery, Surrey,
- a) **Standard In-Ground Lot:** This form of lot is limited to the Interment of the human remains of 1 person and the secondary Interment of the cremated remains of not more than 3 additional persons or, where no human remains Interment is intended in the Lot, the Interment of the cremated remains of not more than 4 persons,
 - b) **Companion (Double Depth) In-Ground Lot:** This form of lot is limited to the Interment of the human remains of 2 persons in a double-depth crypt where, without exception, the first Interment shall be made into the lowest level space within the Lot, and the secondary Interment of the cremated remains of not more than 2 additional persons,
 - c) **Green Burial Lot:** This form of Lot is limited to the Green Burial of the human remains of 1 person and the secondary Interment of the cremated remains of not more than 1 additional person,
 - d) **Single Crypt:** This form of lot is limited to the Interment of the human remains of 1 person,
 - e) **Companion Crypt:** This form of lot is limited to the Interment of the human remains of 2 persons where, without exception, the first Interment shall be made into the furthest back or the lowest level space within the crypt,
 - f) **Single Cremation Lot:** this form of lot is limited to the Interment of the cremated remains of 1 person,
 - g) **Companion (Double) Cremation Lot:** this form of lot is limited to the Interment of the cremated remains of not more than 2 persons,
 - h) **Family Cremation Lot:** this form of lot is limited to the Interment of the cremated remains of not more than 4 persons,
 - i) **Green Burial Cremation Lot:** This form of Lot is limited to the Green Burial of not more than 2 persons,
 - j) **Standard Cremation Niche:** This form of lot is limited to the Interment of the cremated remains of 1 person,

Bylaw Schedule B: Rights of Interment Regulations

- k) **Companion (Double) Cremation Niche:** this form of lot is limited to the Interment of the cremated remains of not more than 2 persons,
- 1.3 Right of Interment Purchase Limit: No person, without prior consent and agreement of the Manager, may purchase the Right of Interment for more than 4 Lots in the Cemetery, where such consent and agreement may, at the Manager's discretion, be withheld.
